

RE: Tewksbury Callout 11/05/12

On Monday November 5, 2012 at approximately 09:30 hours the NEMLEC SWAT team was activated to assist the Tewksbury Police Department with serving a high risk arrest warrant. Upon my arrival at the staging area (Tewksbury PD) I was informed that the target of the warrant was taken into custody during a traffic stop.

Chief Sheehan (Tewksbury PD) related the following case history to me. The suspect had been involved in a shooting in the City of cambridge over the weekend of November 2, 2012.
