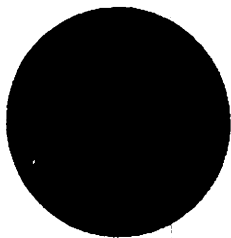

On Tuesday October 16, 2012 the NEMLEC SWAT team was activated in a planned event to assist the Medford Police Department with security and crowd control issues for the visit of the [REDACTED] to the Kurukulla Center. The SWAT team was instructed to stage at the Elks Lodge [REDACTED] Washington Street Medford at 0830 hours.

Upon the teams arrival at the staging area we were given a final briefing by the Operations Section Chief Lt. Mark Rudolph of the Medford Police Department. The SWAT teams mission would be divided between providing a four person immediate action team and assigning the rest of the team to assist Medford PD with any crowd control issues that may come up.

Once deployed the team took up a position in the rear [REDACTED] Magoun Ave. This location allowed access for both the immediate action team and the crowd control element of the SWAT team to the front and rear areas of the Kurukulla Center.

The immediate action team consisted of the following operators;

1. Sgt. Frechette
2. Operator DiChiara
3. Sgt. Fay – Team Leader
4. Operator Saia

The team was positioned in the grey van which was driven by CNT member Sgt. Peaslee. The remaining members of the SWAT team were assigned to crowd control, if needed.

The [REDACTED] visit went as planned and the team was not required to deploy. After de-briefing the event the team was dismissed. The hours of the operation were 0800- 1600 hours.
