

On Tuesday October 23, 2012 at approximately 1730 hours the NEMLEC SWAT team was activated to assist the Lowell Police Department with a barricaded subject armed with a knife. The team was instructed to stage at the Jean D'Arc School Dracut Street Lowell.

Upon my arrival at the staging area I was advised that Lowell PD had responded to Dracut Street regarding a domestic incident in which a son had assaulted his father with a knife. Was intoxicated and has a history of mental health issues. In the had informed the first responding Lowell PD officers that he was not going to come out of the house and was not going to jail.

Upon the arrival of the first SWAT operators; Sgt. Fay, Sgt. Frechette and Sgt. Seamans, superstand surrendered to Lowell PD. After de-briefing the incident the team was dismissed. The hours of the operation were 1730 - 2030 hours.
