

On Tuesday November 20, 2012 at approximately 1700 hours the NEMLEC SWAT team was activated in a limited response to assist the Stoneham Police Department with the potential arrest of an armed robbery suspect. The team was instructed to stage at the Stoneham Police Department at 1800 hours.

Upon my arrival at Stoneham PD I met with Sgt. Tom Heller who briefed me on the investigation/operation. Sgt. Heller indicated that over the past two weeks the towns of Wakefield, Reading, Stoneham and Woburn had experienced a series of seven armed robberies (three occurring in Stoneham). These armed robberies had been performed by a single masked suspect; in each robbery a large caliber handgun was used. As a result of the investigation into the robberies the Stoneham PD Detectives had identified of Stoneham as the primary suspect in the robberies. The Stoneham Detectives had also identified of Stoneham as being involved in the robberies by driving Goulding from the scenes after the robberies.

A task force of detectives from Woburn, Reading, Stoneham, and Wakefield had been formed and they were being assisted by the FBI's Bank Robbery Task Force. The operation on the 20th was for the task force to put Goulding under surveillance when he left his apartment Stoneham brown 1998 Toyota Camry Mass reg

The SWAT team would shadow the surveillance teams in two unmarked vans and be the primary arrest team if attempted /performed a robbery.

The surveillance teams would be assisted by a fixed wing aircraft surveillance team, provided by the FBI's task force. The fixed wing aircraft would be able to track the

suspect's vehicle from a high altitude and this would allow the ground teams to shadow the suspect from a distance.

The responding SWAT team members were split into two teams. The Alpha Team was assigned the grey van driven by Sgt. Heller; the following operators were assigned to the Alpha Team;

The Bravo Team was assigned to the black van driven by Operator Rego. The following operators were assigned to the Bravo Team;

The surveillance teams tracked the suspect for several hours with negative results and the operation was terminated at approximately 2300 hours. After de-briefing the operation the team was dismissed. The hours of the operation were 1700 - 0000 hours.
