

RE: SWAT Callout 418 Westford Street Lowell

On Monday December 2, 2013 at approximately 1800 hours the NEMLEC SWAT Team was activated to assist the Lowell Police Department with a barricaded subject armed with a knife. The team was instructed to stage at 418 Westford Street Lowell. Upon my arrival at the staging area I met with Sgt. Giuffrida (Lowell PD OIC) and Sgt. Herrera (NEMLEC CNT) and was informed that the barricaded subject, To DOB had assaulted several family members with a knife and had caused a great deal of damage to the apartment. The responding Lowell PD officers were unable to convince the surrender and had set up a perimeter around the building.

Sgt. Herrera was able to interview several of family members who informed him that was very intoxicated and had made several statements that he was going to commit suicide by forcing the police to shoot him. Lowell PD also received additional information that way be armed with a shotgun.

Upon the arrival of the first responding SWAT operators an Immediate Action Team (IAT) was formed and took up a position on the $\frac{3}{4}$ corner of the building. Lowell PD officers maintained the perimeter on the $\frac{1}{2}$ corner with the assistance of Sgt. Fay. It was decided once a sufficient number of SWAT personnel arrived that Sgt. Herrera would attempt to make contact with the system from a Lowell cruiser. did not have access to a cell phone and there was no land line into the apartment.

Once Sgt. Herrera announced his presence over the PA system almost immediately appeared on a second floor balcony on the 4 side of the building. Initially indicated that he was going to jump from the balcony but stopped when he was instructed to. Sgt. Herrera requested that the come down to the first floor and exit a rear door, and to come out with his hands up. The complied with the commands and within a short period of time exited the a rear door and was taken into custody by the IAT and handcuffed by Sgt. Gualtieri.

Lowell PD. was charged with Domestic A&B, Assault with a Dangerous Weapon (knife), Wanton Destruction of Property.

The following operators were assigned to the Immediate Action Team:

- 1. Dorsey long arm
- 2. Heller long arm, Taser
- 3. Frechette TL
- 4. Lefebvre long arm
- 5. Bourque shield
- 6. Gualtieri 40 mm less lethal

The IAT along with several other SWAT operators cleared the first and second floor apartments. While clearing the second floor apartment Sgt. Heller and Operators Dicker and Lefebvre made entry into a second floor apartment where they located an individual, It was determined that as the second floor tenant and was playing video games with headphones on and was unaware of the police activity taking place in the building. After clearing the building it was turned over to Lowell PD.

The following operators assisted the IAT with clearing the building:

- 1. Surette long arm
- 2. Dicker long arm
- 3. Seamans Taser
- 4. Max ram
- 5. Paladeau K-9 Westford PD

After taking attendance and conducting a debrief of the operation the team was dismissed. The hours of the operation were 1730 – 1930 hours.
