On Tuesday February 12, 2013 the NEMLEC SWAT team was activated to assist the Medford Police Department's Drug Control Unit with serving a high risk no knock search warrant. The team was instructed to stage at Oak Grove Cemetery in Medford at 0500 hours.

On Monday February 11, 2013 at 1900 hours Lt. Vivolo and I met Det. Leo Sacco and Det. Kevin Braxton at the Medford Police Department to obtain the case background and also develop an operational plan for the mission. Det. Sacco informed us that he had received a no knock search warrant for Jerome Street (search warrants for two vehicles also) from Somerville District Court (no docket number assigned to warrants). Det. Sacco indicated that Jerome Street is a single family home that has been converted into three apartments, basement, first and second floor. The search warrant is for the entire building.

The occupants of Jerome Street are involved in selling cocaine (powder and crack).

and according to Det. Sacco a confidential informant informed him that John Vieira has been seen with a black semi-automatic handgun on numerous occasions. Det. Sacco also informed us that Jerome Street was the scene of a home invasion two years ago where

and are involved in dealing drugs out of the first floor apartment. Det. Sacco informed us that a several occasions had requested his confidential informant purchase an AR15 for him in New Hampshire. Det. Sacco's confidential informant is licensed to purchase in New Hampshire.

The occupant of the basement apartment **the second problem** ecently suffered a gunshot wound reportedly while he was cleaning a weapon in his apartment. According Det. Sacco

Lieutenant Vivolo, Detectives Sacco and Braxton and I performed a reconnaissance drive by of the target location. Once back at the Medford Police Department Lt. Vivolo and I developed an operational plan. The plan called for the Alpha team to make entry into the first floor apartment from a porch door located on the two side of the house. The Bravo team would make entry into the front door then breach a second door inside the front foyer and proceed up a flight of stairs to the second floor. The Delta team would secure the perimeter and also perform a breach and hold on the basement apartment. The entry for the basement apartment was located on the 1 side of the house at the street level. A contingency plan was also covered if the team was compromised or engaged at any point during the operation.

At approximately 0530 hours on February 12, 2013 the SWAT team was assembled a case background and an operational overview was conducted and team assignments were given. The teams then met individually with their team leaders to cover specific assignments. After performing a final brief back the teams loaded into assigned vehicles and proceeded to the target location over a predetermined route. The order of vehicles was Alpha – grey van, Bravo – white van, Delta – blue van followed by the Bearcat.

At approximately 0600 hours the team arrived at the target location and unloaded from the vans. Once in position both the Alpha and Bravo teams breached and made entry. The Alpha team upon making entry encountered in the kitchen area where he was taken into custody without incident by Sgt. Max. A statement was located in the rear bedroom where he was taken into custody without incident by Operator O'Leary. The apartment was turned over to the Medford Detectives.

Once the Bravo team made entry into the second floor apartment was located in the bathroom. (Later learned was flushing drugs down the toilet) was taken into custody without incident by Sgt. Heller and Lt. Vivolo. The suspect's wife was located in the bedroom and placed in a chair in the kitchen. After conducting a secondary search the apartment was turned over to the Medford detectives.

The Delta team after securing the perimeter breached the basement apartment door and made entry into the apartment. A search of the apartment determined that nobody was in the apartment.

Once back at the staging area the operation was debriefed and then the team was dismissed. The hours of the operation were 0400 – 0800 hours.
