On Friday February 21, 2014 at approximately 0300 hours the NEMLEC SWAT Team was activated to assist the Tewksbury Police Department with a barricaded subject. The SWAT Team was instructed to stage at the Tewksbury Police Department 918 Main Street Tewksbury. Upon my arrival at the Tewksbury Police Department I met with Chief Sheehan. Chief Sheehan informed me that at approximately 0230 hours patrol officers from his department responded Foster Road for a report of a disturbance. Upon the arrival of the first officers it was learned that the male homeowner had barricaded himself in a basement bathroom and was making threats.

After being briefed on the situation an Immediate Action Team was formed and sent to Foster Street to replace the Tewksbury officers in the basement. Sgt. Torres of the Tewksbury Police Department was actively engaged in dialogue with Torres continue his dialogue and have him coached by Sgt. Sedgwick of the NEMLEC CNT. At

approximately 0430 medicated that he was going to come out of the bathroom. was taken into custody by Operator Cogswell without incident and turned over to the Tewksbury Police Department.

After clearing state—oster Street the team returned to the Tewksbury Police Department and debriefed the operation. The team then cleared the hours of the operation was 0300 – 0700 hours.
