

SWAT callout to Wilmington

On April 17, 2014 at approx. 1430 hours the NEMLEC SWAT team received a call to stage at Paddock Street for a barricaded suicidal male armed with a handgun. Upon our arrival we learned a white male may be barricaded inside the second floor of Paddock Street. As operators arrived on scene an immediate action team (Alpha) was formed. Just prior to the target location Operators donned their heavy vest and continued to respond.

At this time the Alpha Team set up on the one/four corner of the target location with the Bearcat for cover. While in position we learned the suspect may be in Malden, Massachusetts. This was confirmed a short time later and Malden Police had placed the suspect in custody without incident. No weapons were found on the suspect. The second floor was secured and it did not appear anyone was inside. However, the Wilmington Police did not want to force entry and were awaiting the arrival of a key to the apartment to conduct a protective sweep for any persons or weapons inside. The NEMLEC SWAT Team responded back to the staging area for a debriefing and cleared the scene.
