

SUBJ: SWAT callout to assist Amesbury Police Department

On April 04, 2014 at 1130 hours the NEMLEC SWAT Team received a call to stage at 10 Pleasant Street Amesbury, Massachusetts for a high risk warrant service. Upon our arrival we learned the Amesbury Police had been conducting a narcotics investigation for moveder House Court in Amesbury, Massachusetts. The target location is a standalone condo unit which leads into a complex with only one entry and exit point. The targets ( ) of the investigation have been 1 and dealing in large quantities of herom. The Amesbury Police have several undercover purchases from both targets and have received arrest warrants as well as a No Knock search warrant for is believed to be associated with the Latin Kings gang and may the target location. also has have been involved in a shooting incident in Billerica, Massachusetts. also has two several firearms charges including a firearms silencer on his BOP. I is an MMA who may be present. One of the sons sons fighter and has fought with the Amesbury police in the past.

During the briefing team assignments were being conducted and the Amesbury Police learned the suspects were not home. However, **Second Police** and requested to pick up a motor vehicle accident report she was involved in two days prior. Due to this information it was decided if **Second Police** came by with **Second Police** SWAT Team would conduct a felony car stop at the Amesbury Police Station and then send an entry team to clear the target location. After waiting several hours it was decided not to execute the warrants due to the time of day with children coming out of school. The mission would be conducted the next morning and the SWAT Team would stage at 0500 hours.

On April 05, 2014 at 0500 hours the NEMLEC SWAT Team staged at the Amesbury Police Department located at 127 Rear Main Street Amesbury, Massachusetts. During the briefing we learned an additional male **Constitution** may be present inside along with two unknown dogs. At this time the SWAT Team set up two entry (Alpha and Bravo) teams and a perimeter (Delta) team. The mission was decided the Alpha Team would make entry on the one side front door and clear the second floor while the Bravo Team made entry on the three side glass sliding doors and clear the first floor. The Delta team would secure the perimeter. During the execution of the warrant The Alpha team made forced entry while the Bravo Team entered through the open glass sliding doors. The Alpha Team proceeded to the second floor while the Bravo Team cleared the first floor. The Bravo Team secured one male suspect Operators Palmer and Sgt. Keins. The Alpha Team secured three parties

on the second floor. There were also five dogs on scene

which were secured in the bedroom on the first floor. Once all parties were secured a secondary search was completed and the scene was turned over to the Amesbury Police for further investigation. The SWAT Team responded back to the staging area for a debrief and cleared the scene.
