RE: SWAT Callout Stoneham

On Wednesday May 1, 2013 at approximately 16:00 hours the NEMLEC SWAT Team was activated to assist the Stoneham Police Department and the Southern Middlesex Regional Drug Task Force with serving a high risk search warrant. The team was instructed to stage at the Stoneham Police Department. Upon my arrival at the Stoneham Police Department I met with Detective Paul Norton, Det. Norton informed me that he had applied for and obtained a knock and announce search warrant for narcotics out of Woburn District Court docket number Pomeworth Street Stoneham. The targets of the investigation and pare dealing large quantities of crack cocaine. Both suspects have extensive criminal histories with felony convictions.

The target location at Pomeworth Street is a large single family house with a basement apartment and a detached garage. According to Det. Norton the basement tenant, (father of the last of the last

After receiving the case briefing a reconnaissance drive by of the target location was conducted by the team leaders and vehicle operators. After the reconnaissance drive by was completed an operational plan was developed. The Stoneham Detectives had requested that a team of SWAT operators conduct a motor vehicle stop on the suspects as the suspects returned to Stoneham after picking up narcotics in Chelsea.

The operational plan called for the Bravo Team to conduct the motor vehicle stop on the suspects and simultaneously the Alpha Team and Charlie Team would make entry on the front door (side 1). The Alpha Team would clear the first floor and the Charlie Team would clear the second and third floors. The Delta Team would make entry on the basement apartment; the door for the apartment was located on side 4 of the house. The perimeter

of the home would be secured by the NEMLEC K-9's and detectives from the Southern Middlesex Regional Drug Task Force. The knock and announce of the search warrant would be made by the Alpha Team.
