

On Monday May 5, 2014 at approximately 1730 hours the NEMLEC SWAT team was activated to assist the Danvers police Department with serving a Section 12 on a suicidal male. The team was instructed to stage at the rear of 182 North Street Danvers. Upon my arrival at the staging area I met with members of the Danvers Police Department command staff. I was informed that the Danvers Police Department had obtained a section 12 for Reservoir Drive Danvers. According to the Danvers Police, had recently been terminated from the State Police as a result of a severe drinking problem. Trp. Steven Salsman of the Employee Assistance Unit informed me that he has been working with a during his termination process and that today had called a support line and indicated that he was going to kill himself; this call had prompted the process of the Danvers PD obtaining a Section 12. Trp. Salsman also informed me that the was a police officer who had committed suicide.

Danvers PD had not yet attempted to serve the Section 12 on but wanted the SWAT team staged nearby if the situation turned into a barricaded subject. It was unknown if was in possession of a firearm. It was at this point that Sgt. James Deyermond (MSP) approached the command staff of the Danvers Police Department and indicated that he was on the phone with the same and that was aware of the Section 12. Sgt. Deyermond was confident if he went to the house that would come right out.

It was decided that a team of operators and negotiators along with Sgt. Devermond would go to house in attempt to have him come out. Once the team was in place Sgt. Devermond made contact with from the driveway, after a few minutes Sgt. Devermond stepped inside the home with the same Approximately 5 minutes later Sgt.

Devermond and existence exited the house and Danvers PD took control of transported him to the hospital. The team then returned to the staging area and conducted a debrief of the operation.
