On August 27, 2013 the NEMLEC SWAT Team received a call to stage at the Somerville Police Department on August 28, 2013 at 0500 hours for a high risk warrant service. Upon our arrival we learned the Somerville Police had obtained an arrest warrant (WR4942150TC and WR4942152TC) for an Hispanic male suspect (

Massachusetts. The target house is a three family home and is occupied by the suspect, the suspect's mother friends who may reside there on occasion. The target has been involved in numerous B&E's (over 100) and is believed to be in possession of firearms which were stolen in several breaks this year. The target is also a suspect in a recent home invasion that occurred in February this year at George Street Somerville, Massachusetts where the target had dropped his identification and a handgun at the crime scene.

At this time we set up two entry (Alpha and Bravo) teams. The perimeter would be secured by the K-9 Units. The mission was for the Alpha Team to make entry through the one side of the house and proceed to the second floor while the Bravo Team held their position on the two/three corner and standby for support request through the Alpha Team. The Alpha Team would conduct a knock and announce with the Somerville Detectives and standby to assist if the suspect refused to come out.

During the mission the teams proceeded to the target location and a five count was executed. The order of movement was Alpha and Bravo. The K-9's were assigned to the entry teams when deployed. Once the teams exited their vehicles the Alpha Team made entry on the one side of the house. Upon entry the Bravo Team staged at the rear door located at the two/three corner. The Alpha Team conducted a knock and announce and identified themselves as the "police". This knock and announce was initiated at least three times until the mother answered. The Alpha Team along with Captain Femino from the Somerville Police Detective Bureau ordered Mission to open the door. After several request Mission opened the door and we requested to come out. Captain Femino asked Miss and the state of a bedroom located on the four side of the target house. Operator Saia ordered and the to come out several times. The just stared at the Alpha team and refused to comply or say anything. At this time the Alpha Team made entry and placed and the four side of the target house. Dichiara and Rego. The Alpha Team continued to search the apartment for additional personnel and discovered the sister located in the back bedroom on the three/four corner of the house.

Once the apartment and suspect was secured it was turned over to the Somerville Detectives for further investigation. The SWAT Team responded back to the staging area, debriefed and cleared the scene.
